ARTICLE VI - HEALTH INSURANCE

Effective January 1, 2014:

- A (1) Change to Advantage Modified EPO Plan (Summary attached hereto).
- B (1) Change prescription co-pays to the following:

\$5.00 - generic \$20.00 - brand-name \$40.00 - non-preferred brand Mail Order - 90 day supply = 1x above-noted co-pays

G(1) Revise to provide that retiree medical coverage becomes secondary upon qualifying employees receiving Medicare coverage.

ARTICLE VII - HOURS OF WORK AND OVERTIME

Sections B, C & F – Revise to provide that overtime is all work beyond forty (40) hours in a defined workweek. Sick leave shall not count as hours worked for overtime purposes.

ARTICLE XIV - SALARY AND LONGEVITY

Add 1 additional step to existing salary guide; January 1, 2012 as set forth below. The salary guide set forth below shall be increased as follows: 2% - January 1, 2013; 2% - January 1, 2014; 2% - January 1, 2015:

Step 2 - \$36,900.00

Step 3 - \$40,800.00

Step 4 - \$44,700.00

Step 5 - \$48,600.00

ARTICLE XXI - PART-TIME DISPATCHERS

Add additional sentence to first paragraph, which will read as follows: "The Township can also utilize part-time dispatchers as needed so long as full-time dispatchers are provided the right of first refusal for such overtime opportunities."
