BE IT FURTHER RESOLVED that all appropriate officers and employees be and hereby are authorized and directed to execute such documents and take such further actions as are necessary to effectuate the purpose of this resolution.

Memorandum Of Agreement

Memorandum of Agreement by and between Teamsters Local 11, affiliated with the International Brotherhood of Teamsters, located at 810 Belmont Avenue, North Haledon, New Jersey and Passaic County Roads Department, located at 401 Grand Street, Paterson, New Jersey.

It is hereby agreed that the following items shall constitute the changes negotiated and agreed to between the parties.

- Term of Contract Five (5) years.
- 2. Article 5 Work Week

Section 2B Change to read — Golf Course Employees March 1 to October 31 — During the months in which no regular scheduled work will be performed on weekends, the County will schedule one (1) employee for any work scheduled on Saturday and Sunday, whenever a supervisor is scheduled to work. Such work shall be rotated between the employees on the seniority list for weekend work. The start time for week end work will be 7:00 am with a three hour guaranteed work day.

3. Article 6 - Hours of Work

C – Change dates to read:

April 1 through September 15

September 16 through March 31

4. Article 7 - Rate of Pay

Section 1 - Change to 2½ percent increase to base salary

Section 2 - Change to 2½ percent increase to base salary

Section 3 – Change to 2½ percent increase to base salary

Section 4 – Change to 2½ percent increase to base salary

Section 5 - Change to 2½ percent increase to base salary

Add - Step 10 to all salary guides.

Section 12 – In the event an employee is temporary transferred to a higher rated position and performs the duties of that classification for eight (8) hrs or more the employee shall receive the next higher rate of pay for higher classification for the entire day. It is understood that no employee shall receive a lower rate of pay to their own when transferred to a higher classification. In any event if an open higher rated position is filled for more than thirty days by a temporary employee the County will than follow Article 20 – Job Vacancies, New Jobs Created, of the Collective Bargaining Agreement. (Open positions for the following reasons: F.M.L.A., Workmen Compensation, disability, leave of absence, or any temporary vacancies which the employee will return shall not apply to this Article).

Section 13 – New – In case of any emergency within Passaic County which requires the County to close one (1) or all of its locations employees who must remain in their position shall receive 1 ½ times their hourly rate for all of the hours worked after the emergency was called within those locations.

5. Article 8 - Pay For Time Not Worked

Section 1 – Holidays Eliminate – Lincoln's Birthday

6. Article 10 - Paid Sick Leave

Section 5 – Change to read: One (1) hour prior to their starting time

7. Article 12 - Bereavement Leave Pay

Add – Legal Guardian Add – Domestic Partners

8. Article 14 - Health Benefits

The Employee may choose at no cost the following insurance coverage.

Horizon Direct Access Plan, which is a non-gated plan (no referrals) with a very good network in NJ.

100% in network, \$15.00 co-pay for office visits <u>No</u> deductible 80% out of network after \$200 deductible.

9. Article 15 - Uniform & Safety Equipment

Section 1 – Add – winter jump suits.

Add New Section 1a – during the winter months the Employer will provide vinyl enclosures for all golf carts being used on the golf course at all times.

Section 2 – Change to read – Work gloves shall be provided as needed and required. OHSA approved goggles and face shields. In addition the Employer will provide safety cages on all new riding mowers.

Section 5 – Tool Allowance – After the word "mechanic" add "Welder" for each year of the Contract.

Section 6 – The County will provide safety cages on existing equipment whenever possible.

10. Article 18 - Seniority

Section 1 – Add – All job assignments will be assigned by seniority with the skill and ability to perform the work. Add new language – Add the following titles to the contract:
