**WHEREAS**, the Borough and Union wish to enter into this Sidebar agreement for the purpose of providing members with temporary relief from the full implementation of Chapter 78 health care contributions; and

**WHEREAS**, this temporary relief shall roll back members' Chapter 78 contribution to Tier III for calendar year 2025 only, after which, contributions shall revert back to Tier IV full implementation, unless other terms are negotiated in a successor agreement.

NOW, THEREFORE, in consideration of the foregoing, the Parties agree as follows:

- 1. Article V, "Health Benefits," of the CNA shall be amended for calendar year 2025 only to provide that members' health care contributions shall be three-fourths (3/4) of the amount required by the full implementation of employee health care contributions pursuant to Chapter 78;
- 2. The Parties expressly acknowledge that this relief shall be for one-year only, notwithstanding the expiration of the current CNA on December 31, 2025. Accordingly, the Parties expressly agree that members' health care contributions shall be at Tier IV full one hundred percent implementation of Chapter 78 health care contributions effective January 1, 2026, unless other terms are negotiated and agreed to in that successor agreement; and
- 3. No other Article of the current CNA shall be affected by entering this Sidebar agreement. This Agreement shall not be precedent setting, nor establish any past practice in any manner whatsoever between the Parties.
