SIDEBAR AGREEMENT

The TOWNSHIP OF CHATHAM ("Township") and PBA LOCAL NO. 170 ("Union"), are parties to a collective negotiations agreement ("CNA") effective January 1, 2020 through December 31, 2023;

WHEREAS, Officer Philip Masi, a member of the Union, was hired on April 16, 2022 in the rank of "Probationary Patrolman" and is a party to this Sidebar Agreement ("agreement");

WHEREAS, Officer Masi is presently on Grade 9 of the step guide governing salaries of officers in the Union;

WHEREAS, Masi's experience gained at other police departments prior to commencing his employment in the Township exceeds that expected of Township police officers in his Grade;

WHEREAS, the Township would like to increase Masi's compensation commensurate with his overall experience as a police officer notwithstanding his relatively brief seniority as an officer in the Township's police department..

IT IS HEREBY AGREED AS FOLLOWS:

- 1. Effective July 1, 2023, Masi shall be advanced to Grade 8 of the step guide and shall advance annually along the guide from that Grade;
- 2. Masi shall retain seniority for all contractual and other purposes from his initial hire date of April 16, 2022 notwithstanding this agreement to advance him on the step guide.
 - 3. Nothing in this agreement or the negotiations leading to this agreement shall

be precedential in the future for any purposes between the parties.

- 3. That the Side Bar Agreement and negotiations leading to the agreement would not constitute precedent for future negotiations between the Township and the PBA;
